## ADDITIONAL INFORMATION

- **New applicants**—half of the site survey or consultative visit fee must be paid the year prior and should accompany the letter of request—see policy AC-130 for details/deadlines.
- **For additional survey team members**—site survey fees are based upon the required number of surveyors. A hospital may elect to have additional site surveyors join the team for an additional fee (per reviewer)—see policy AC-119. Contact [Amy Krichten](#) for further information.
- **Grant opportunities may exist**—Critical Access Hospitals (CAH) undergoing consultative visits or site surveys may be eligible for waived or discounted fees based upon availability of grant funding provided to PTSF by the Medicare Rural Hospital Flexibility Grant Program administered through the Pennsylvania Office of Rural Health. - **Level 4, focused 2-year panel reviews**—see policy AC-139, “Level 4 Trauma Center Reaccreditation” for eligibility; contact [Amy Krichten](#) for further information.
- **Billing cycle**—trauma center fee invoices are sent no later than November 1<sup>st</sup> [for the following year’s fees] and are due to PTSF by January 15<sup>th</sup>. Fees are billed annually.
- **Pro-rated Fees**—hospitals that become accredited will be billed for pro-rated Participation Fees within two-weeks of the accreditation decision, and those fees are due to PTSF on their accreditation date.
