It is my great honor and pleasure to serve as board chair this year for the Pennsylvania Trauma Systems Foundation. The PTSF has been a leader in improving trauma care for injured Pennsylvania citizens since its inception in 1985 when it was tasked in the EMS Act to serve as the accrediting body for trauma centers. Since then, we have led the way in standardizing trauma care across the state. There's no question that we continue to strive for our mission statement of "Optimal outcomes for every injured patient" in Pennsylvania.

We have accomplished many things over the past 40 years, including our statewide data system, the expansion of Trauma Centers throughout the state, and supporting hospitals in rural areas to seek and attain trauma accreditation to address regional trauma care gaps, to name a few. We look forward to taking on new challenges.

Over the next year, PTSF is excited to build and implement new software products with IQVIA. We anticipate this initiative will improve and modernize our data collection, streamline our research efforts, and allow us to evolve to suit the needs of our trauma programs. PTSF staff have worked tirelessly to bring this software initiative into being, and we are excited for our trauma programs to have access to the software soon.

We hope to be able to expand the excellence of our own trauma system to other states. Over many years, our PTSF staff and board members have mentored other states to elevate their designation processes and standards of care stand. Other states reach out to us for support since we are seen as a national leader in this realm.

The number of accredited trauma centers continues to grow in Pennsylvania. Currently, we have 52 trauma centers encompassing 55 trauma programs, with six more pursuing trauma accreditation. We have an amazing and dedicated staff, led by Juliet Altenberg, who are dedicated to elevating trauma care delivered to the citizens of Pennsylvania. I believe we are actively fulfilling the goal of establishment of the PTSF, and it is my great honor to work with our board and incredibly dedicated and knowledgeable staff to push our mission forward!

2024 ESO Annual Update

As previously communicated, the 2024 Annual Update has been delayed; however, ESO has communicated that it should be made available within the next few weeks. PTSF fully understands the severe consequences of this delay and the current inability to validate 2024 records for TQIP submission. We will continue to assist and support PA trauma centers to the best of our abilities.

In the meantime, PTSF staff recommends abstracting patients with 2024 admission dates within the 2023 software until the 2024 software is installed. Also, do not delay the submission of any 2024 records to the PTSF. Once the 2024 software is installed, updates will be required to be made within 2024 records that were originally abstracted in the 2023 software. Once these 2024 records are updated within the 2024 software, they should be reclosed and resubmitted to the PTSF. Note that resubmissions do NOT impact the timeliness of submission.

Note, minimal changes to the software and both the PTOS and NTDS datasets were made for 2024 admissions. Please refer to the PTOS/Collector Change Document and the 2024 Annual Update webinar posted on KnowledgeConnex for more information related to these changes.

Board of Directors Policy (BD-109) Non-Board Committee Membership:

To better clarify expectations of PTSF committee membership, the PTSF Board approved several additions and revisions to BD-109 – Non-Board Committee

Membership policy. Changes include updating the purpose statement to define non-board committee membership, committee composition, and the overall goals of PTSF non-board committees more clearly. Committee conduct requirements were also added in addition to updating the duties of the committee chair.

<u>Accreditation Policy (AC-128) Notification Regarding Changes in Trauma Center Operations for Pursuing and Accredited Trauma Centers:</u>

Updates to <u>AC-128</u> were approved by the Board to offer additional information to trauma centers on when PTSF should be notified regarding changes in Trauma Center Operations. Changes included:

- The need for centers to suspend trauma services beyond temporary emergency department closure/diversion were amended to read suspend or remove. Examples of the suspension or closure were amended to include level III or IV non-essential services.
- Guidance was added for level III and IV trauma centers that have an addition of or change in physician specialty services. Additional guidance includes examples.
- Language was also added to change "Trauma Center Contact" to "Hospital Administrator Trauma Center Contact".

2024 PTSF HOSTED TRAUMA CENTER EDUCATION

Tuesday, April 16th | 10:00 a.m. to 3:00 p.m.: New Trauma Program Nurse Leader Orientation – Virtual

• New trauma program nurse leaders from both pursuing and accredited centers are invited to join PTSF staff for this course which is taught by a variety of PTSF staff members. Topics include National Trauma Organizations and Resources, the American College of Surgeons (ACS), the PTSF, Trauma Registry, Trauma Performance Improvement, Site Survey & Accreditation, Trauma Program Resources, and "Hot Topics in Trauma." The primary audience includes new Trauma Program Coordinators/Managers, Trauma Program Directors, Performance Improvement Coordinators, Nurse Registrars, Educators, and other nurse leaders working with the trauma program. August 5th-9th*: Free Software Super Users Education at the Sheraton Harrisburg Hershey Hotel

- Each Trauma Program is invited to send up to four (4) super-users to in-person training. The PTSF recommends that each Trauma Program should have the following staff members attend the training: TPM, PIC, Registrar, plus one additional individual. Please register all super-users from your program to attend on the same day! Ideally, one representative from each hospital will register the entire team at once. The training is a full eight-hour day (estimated 8:30 a.m. to 5:00 p.m.).
- A hotel room block is available with discounted room rates for attendees. Please book your room as soon as possible due to limited availability. The PTSF encourages you to coordinate with your trauma program and book early to reserve your room through this <u>link</u>.
- *Friday, August 9th is reserved primarily for staff from hospitals pursuing trauma program accreditation or those with limited experience with the current software. If this does not apply to you, please avoid registering for the Friday training unless there are no other options for your team.
